2. The District Level Committee on Disability shall perform the functions as prescribed in Rule 11 of Telangana State Rights of Persons with Disabilities Rules, 2018. The Collector and District Magistrate and Chairperson of the committee shall nominate the persons as indicated at points (XVI) & (XVII) of the above table.

3. All the Collectors & District Magistrates in the State shall take necessary action in the matter.
