- d) To perform such other functions as may be prescribed by the State Government.

4. The tenure of the above Committee shall be for a period of 2 years.

5. The above said Committee shall meet atleast once in sixmonths to advice the State Government on effective implementation of the Act and to

advicetheStateGovernmentoneffectiveimplementationoftheAct and to perform such other functions in relation toTransgender.
